NOTICE 31.07.2023

The University is in receipt of complaints from several sections of the Society (Faculties, General public, Representative of people) that many of the Self-financed B.Ed. Colleges are- 1. Depriving the student community by not appointing the NCTE prescribed number of faculties. 2. Discharging the faculties after appointment but keeping their names in the ERC Faculty list and thus trying to mislead the NCTE and the Affiliating University. 3. Not making the payment salary of the faculties through Banks leaving ample scope for misrepresenting the amount of salary paid and even misrepresenting the number of Payees (faculties). 4. Not having Fire safety Certificates as prescribed in the NCTE regulations 2014.

In view of Agenda 6 of the 13th E.C. meeting Dt. 30/06/2023 that the NCTE Regulations 2014 needs to be complied with, the University scrutinised the information and documents provided on request, by different colleges, at different times.

The University, for the benefit of the larger section of the students (through more number of colleges), had so-far, allowed the colleges, chances (by renewal of affiliation) to improve their infrastructure, on the basis of their Undertaking (to remove the deficiencies within a short period of time). But many of the Colleges did not fulfil the terms of their undertakings.

It is also noteworthy that immediately before the renewal of affiliation some of the colleges apply for interview of 9/10 faculties at a time, which in-turn indicates that these colleges are practically running without teachers. The students are thus deprived by these colleges from the opportunity of learning. They are paying the Government stipulated fees that ranges to Rs.1.5 Lakhs and are not getting the return of their family's hard earned money. The colleges are supposed to run on

No Profit No Loss Basis. But if faculties are not engaged, if the engaged faculties are paid very meagre amount of salary and that too, still in cash (where chances of misrepresenting is high) how the principles of No profit no loss be maintained.

Accordingly, on request from the University, to provide infrastructure related information and documents, many of the colleges had complied with such requests. The documents/ information so collected were duly scrutinised. University will start the renewal of affiliation on and from 05/08/2023. Link for the process, will be given only to those colleges who have complied with the provisions of NCTE 2014 Regulations. - If any college finds that in-spite of fulfilling all prerequisites, the University has mistakenly not given it the link, such college is requested to approach the University with proper authenticated documents for rectifications. For correction of any mistake of any kind, the colleges need not pay any fees to the University.

It is also to be noted, that non-renewal of affiliation of any particular college will in no way affect the continuity of studies of any of the existing students.
